# ROBINSON TOWNSHIP

As a valued customer of Waste Management, you now enjoy Single-Stream Recycling.  
All of your recyclables can be placed together in the same bin – no sorting required!  
The following can be placed together in your curbside toter:

- ⊗ Aluminum food and beverage containers with food debris removed; Labels do not need to be removed
- ⊗ Glass food and beverage containers with lids and food debris removed; Labels do not have to be removed
- ⊗ Natural and pigmented placed narrow-neck containers with symbols 1, 2, 3, 4, 5 and 7 (milk bottles, water bottles, detergent bottles, shampoo bottles, bleach bottles, etc.); Food and beverage debris must be removed; Labels do not need to be removed; Lids must be attached to the bottle
- ⊗ Ferrous (Iron, steel, tin) cans with food debris removed
- ⊗ Food and beverage cartons such as milk, soup and broth. Lids must be removed
- ⊗ Newsprint – black and white or pigmented; Not bound or placed in bags
- ⊗ Construction paper, kraft paper, cereal boxes, shoe boxes, or similar
- ⊗ Printer paper, computer paper, copy paper
- ⊗ Junk mail
- ⊗ Magazines, catalogs
- ⊗ Corrugated cardboard must be flattened and cut, and can be no larger than 14 x 14 inches

## List of Materials **Not Accepted** as Recyclables:

- ✗ Any material with food debris
- ✗ Polystyrene foam, foam cups, dinnerware, packing foam or peanuts, etc. of any kind
- ✗ Any item smaller than 2" in diameter or larger than a five-gallon bucket
- ✗ Mirrors, window or auto glass, porcelain, ceramics, glass cookware/bake ware, microwave oven trays, drinking glasses, perfume/cologne bottles
- ✗ Household items such as toasters, cookware, bake ware, electronics, appliance, etc
- ✗ VHS/Cassette tapes and ribbon
- ✗ Items containing or having debris and residue containing hazardous or toxic substances such as paint cans with wet paint, motor oil containers, gasoline cans, glue, petroleum products, etc
- ✗ Hazardous or toxic substances
- ✗ Political campaign signs
- ✗ Unnumbered plastics
- ✗ Batteries of any kind
- ✗ Coat hangers, wire
- ✗ Wood or yard waste
- ✗ Wrapping ribbon
- ✗ Rubber hoses
- ✗ Holiday lights
- ✗ Light bulbs

**Service Notice:** If a Holiday falls on or before your service day, service will be one day later. If the Holiday falls on a Saturday or Sunday, There will be no change in service.

## Home Collection Program for Household Generated Special Materials

As part of the residential solid waste and recycling contract with Waste Management, effective October 1, 2015, you have a convenient new opportunity to dispose of your household generated special materials- safely, easily and responsibly. Introducing the At Your Door Special Collection<sup>SM</sup> program, a residential service offered by Waste Management to provide year-round collections for you.

## HOW DOES IT WORK?

### 1. To Participate, you must set up a collection appointment.

There are three ways to schedule a collection:

The Call Center operators will guide you through the steps toward a safe and successful collection. You will be asked several questions, including your address and the type and amount of materials available for the pick up. You will be provided a convenient collection date and information about where to place the kit for collection. A kit will be sent to your home in plenty of time for you to gather and pack your materials.

### 2. Preparing for collection

The collection kit includes an instruction sheet and other items to help pack and secure your household generated special materials. Please read the instruction sheet included in the kit.

### 3. Material is collected

On the scheduled date, the customer service technician will collect materials directly from your home. They will sort and pack the materials for proper transportation, recycling and disposal. Participants will receive a postage-paid survey card to complete and mail back to help track the program.

### 4. You have more material than will fit into the Kit?

Remember, this service is available year-round. Just schedule another collection! Small quantities may be combined with your neighbors. Call Center Representatives are available from Monday - Friday 8:00 AM - 8:00 PM ET. Leave a message after hours, weekends and holidays. **Managing Household Hazardous Waste:** The best method of managing Household Hazardous Waste (HHW) is to prevent its generation in the first place. This involves selecting the least toxic item "to do the job" and buying only the minimum amounts necessary. Buying in large quantities is not a bargain if half of it has to be discarded. In the future, please consider buying environmentally friendly products.

#### Did You Know?

Latex paint is not a hazardous waste. It can often be donated to community groups and other organizations for re-use. Please consider this option before disposal.

Used motor oil is not hazardous, but may pollute our groundwater, waterways and soil if not properly managed. Many automotive station, auto parts and supply stores will accept used motor oil for recycling.

Automotive batteries may be exchanged at the place of purchase. Many battery retailers offer recycling even if you are not purchasing a new battery. In some cases, there may be a charge. Some scrap yards will also purchase lead acid batteries.
